

What Are Your Rights?

- 1st Amendment
 - Protects the rights of speech and assembly
- 4th Amendment
 - Protects against unreasonable stops, searches, or seizures without a valid legal basis.
 - Requires a judicial warrant to enter private property (areas where there's a reasonable expectation of privacy).
- 5th Amendment
 - Due process and equal treatment under the law





What Are Your Rights?

- US Citizens (USCs)
 - DHS officers (ICE & CBP) generally do NOT have jurisdiction over USCs
 - USCs are not required to carry proof of citizenship—including naturalized citizens
 - Officers can detain USCs in limited circumstances:
 - Belief the person is assaulting, resisting, opposing, impeding, intimidating, or interfering with a federal officer in the scope of their duties
 - Reasonable suspicion they are in violation of immigration laws (i.e. “Kavanaugh Stop”) based on a totality analysis considering factors such as “apparent ethnicity”, “high-crime area”, areas with a “high percentage of illegal immigrants”, gathered at a place where “individuals tend to...seek daily work...in certain kinds of jobs.”

What Are Your Rights?

- Lawful Permanent Residents (i.e. Green Card Holders)
 - All LPRs over 18 years of age are required by law to carry their green card (Form I-551). 8 USC 1304(e).
 - Violators subject to \$100 fine and/or up to 30 days in jail
- People in Nonimmigrant Status (H-1B, TN, F-1, etc.)
 - Required to carry proof of status



Documentation Recommendations

Documents for People in Nonimmigrant Status

- Individuals in lawful nonimmigrant status in US (such as H-1B, F-1, J-1, TPS or HP status) are required to carry proof of legal status at all times.
- The following documents should be carried:
 - **Valid/unexpired Passport or a REAL ID driver's license (or paper copy);**
 - **I-94 record** [Most recent record may be attached at bottom of most recent I-797 USCIS Approval Notice or from more recent reentry to US [here](#)];
 - **Copy of Current Status Documentation, which varies according to status as follows:**
 - F-1 Students – Form I-20 (signed)
 - J-1 Scholars and Exchange Program Visitors – Form DS-2019 (signed)
 - H-1B Professional Employees – Form I-797 Approval Notice
 - Other Statuses – You should contact your immigration attorney to determine what specific documentation is required to document your registration and lawful nonimmigrant status.

Documents for Lawful Permanent Residents & US Citizens

- Lawful Permanent Residents should always carry a copy of their green card.
- US Citizens are not required to carry documentation of status, but they are advised to carry the following:
 - Driver's license, and
 - Copy of US passport biographical page OR Copy of naturalization certificate



Other Documentation Recommendations

- If you do not have valid immigration status but applied for status or have an open case (such as pending asylum application, open immigration court case, or an immigration appeal), carry any document showing you applied for status or are appealing a decision
- If you are undocumented, carry proof of physical presence in the U.S. at least 2 years:
 - Mortgage or rental contract
 - Church or school records with a mailing address
 - Utility bills or bank statements with a U.S. address

Document Safeguarding and Retention

- Advisable to retain copies of relevant documents on electronic devices (including cell phone)
- Copies should be saved locally on your device in an organized folder that is easy to access without internet
- Paper copies of relevant docs should also be kept on your person & in other secure places (car, backpack, wallet/purse)
- If original required documents are lost, stolen, or destroyed, replacements should be promptly requested & the receipt notice for replacement application should be carried

Additional Personal Safeguards

- Emergency contacts should be updated with employer, daycare, schools, etc.
- Trusted contacts should be given copies of relevant documents
- Business card for immigration attorney (if appropriate) should be carried
- Know Your Rights card
- Delegation of Parental Authority should be considered in the event parents might be detained/separated from children
- Consider guardianship and/or Power of Attorney documents
- Communication Plan



Practical Guidance and Best Practices if Stopped by ICE

On the Street

- Stay calm and don't run, argue, resist, or fight the officer, even if you believe your rights are being violated or you are being treated unfairly. Keep your hands where police can see them.
- Always be truthful. Do not lie about your status or provide false documents.
- Ask if you are being detained or free to leave.
- Prove status if comfortable.
- Exercise your right to remain silent if needed.
- Do not sign anything without speaking to a lawyer.

At Your Home

- Do not open your door or consent to entry. Teach all household members (especially children) not to open the door or allow strangers inside your home.
- Ask to see a judicial warrant signed by a judge or magistrate. Have them slide it under the door for your examination.

Traffic Stop

- Ask if the agent is a local or state police officer. ICE and CBP do not have authority to conduct general traffic stops (for speeding, registration violations, etc.)
- Keep your hands visible and articulate to the officer your body movements.
- Do not step outside your vehicle or consent to entry into your vehicle.
- Ask if you are being detained or free to leave.

What if I'm Detained?

What if I'm Detained?

- You have the right to:
 - Remain silent
 - Call a lawyer (You must find your own immigration lawyer--the government does not appoint one for you. You may ask for a list of free or low-cost lawyers or legal services organizations.)
- Find out if you are eligible for bond, parole, or release on recognizance.
- Do not sign any documents—especially if they say “waiver”, “stipulated removal order”, or “voluntary departure agreement.”
